

## **Terms and Conditions**

- 1. The Promoter of the prize draw is InfoTrack Limited with company number 09474590 and registered office address 10 John Street, London, WC1N 2EB (the "Promoter").
- Upon user registration in accordance with clause 5 and the purchase of certain services from InfoTrack or Search Acumen in accordance with clause 3 ("Registered User"), a Registered User shall be automatically entered into the prize draw.
- 3. Entries will be immediately and automatically entered into the prize draw upon each eCOS® (including Verification of Identity, Anti-money Laundering ('AML') checks and Verification of Funds), Official Local Authority Search ('OLAS'), or Regulated Local Authority Search ('RLAS'), Indemnities, Property Report, Contract of Sale, AP1 populated from Deeds, SDLT or Enquiries through InfoTrack or Search Acumen's platform by a Registered User.
